Criteria for Satisfying the CKA

A customer who satisfies ANY of the following criteria may be assessed to have fulfilled the requirements of the CKA.

1 <u>Investment Experience</u>

Investment experience of 6 or more transactions in the preceding 3 years in Investment Funds/Investment Linked-Life Insurance Policies or other Unlisted SIPs*.

* Includes Premium Account, Currency Margin Trading, Structured Notes, Structured Deposits, FX Options.

¹Excludes investment experience in:

- stocks or shares;
- fully-paid depository receipt representing shares;
- subscription rights pursuant to rights issues;
- company warrants;
- units in business trusts / real estate investment trusts;
- debentures (other than asset-backed securities and structured notes);
- life insurance policies (other than investment-linked life insurance policies); and
- contracts or arrangements for the purpose of foreign exchange trading (other than derivatives of
- foreign exchange contracts and leveraged foreign exchange trading).

2. Work Experience
